To help avoid soiling carpets, allow product to dry completely before walking on treated areas.

This product must not be used on pets. To protect your pet against fleas outdoors, use a Vet•Kem® flea and tick collar, pet spray, pet topical, or pet shampoo.

FIRST AID

PRECAUTIONS AND RESTRICTIONS

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying.

Do not allow adults, children, or pets to enter the treated area until sprays have dried.

Not for broadcast use on indoor residential surfaces.

Do not contaminate food and foodstuffs. Do not use in the edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared, processed, stored, or served.

DO NOT SPRAY ON PETS OR HUMANS.

Shake well before using.

Fleas: For maximum effectiveness, treat entire carpeted area. Use in homes, garages, attics, apartments, and hotels. One bottle will treat a surface area equivalent to approximately three 10' X 10' rooms. Apply as a uniform spray to kill fleas. Avoid wetting furniture and carpeting. Treat carpets, rugs, drapes and all surfaces of upholstered furniture. Remove old pet bedding and replace with clean fresh bedding after treatment of pet area. Retreat as necessary.

To kill ticks, roaches, silverfish, earwigs, and ants in the home, garage, attic, apartment, or hotel, apply directly to pests.

Bed Bugs: Thoroughly inspect areas of suspected bed bug infestation and note potential or actual sites where bed bugs hide. Remove or pick up clothing and other obstacles that prevent thorough inspection or treatment. Remove and sanitize infested bedding, clothing, or other items. **Do not apply to bedding. Wash bedding and dry using medium to high heat to kill bed bugs.**

Apply to areas where bed bugs live, especially hidden sites. Apply thoroughly as a spot, crack and crevice, or surface application. Focus applications to hidden sites such as behind dressers, cove base, under carpets and furniture, inside and on box springs, under beds, behind mirrors and pictures, and other locations where bed bugs hide.

Apply as a surface application to carpeting, drapes, and flooring at the rate of ¼ fl oz per 3 ft² (about 8 pumps). Apply directly to mattresses, **do not saturate the mattress**, focus applications on seams and folds. Allow mattress to dry thoroughly before replacing bedding.

STORAGE AND DISPOSAL: **Pesticide Storage:** Store in original container away from children. Protect from freezing or high temperatures. **Container Disposal:** Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
