2. Separate one tube from the others. Hold the tube with notched end pointing up and away from the face and body. Use scissors to cut off the narrow end at the notches along the line.

#### How to Apply:

1. Invert tube over dog and use open end to part dog's hair.
2. Squeeze tube firmly to apply all of the solution to the dog's skin as a spot to the dog's back between the shoulder blades.

**Only For Dogs Weighing 55 lbs. or greater. Do not apply to dogs weighing less than 55 lbs. Do not use two tubes on dogs greater than 55 lbs. Apply one tube 4.0 mL (0.135 fl oz) directly to skin as a spot to the dog's back between the shoulder blades.**

#### FREQUENCY OF APPLICATION
