The insect growth regulator pyriproxyfen in SENTRY® HOME Home and Carpet Spray will prevent flea eggs from hatching into biting adults for up to 210 days. **PRECAUTIONARY STATEMENTS • HAZARDS TO HUMANS AND DOMESTIC ANIMALS • WARNING:** Causes skin irritation and substantial but temporary eye injury. Do not get in eyes, on skin, or on clothing. Wear face shield or goggles. Prolonged or frequently repeated exposure may cause allergic reactions in some individuals. FIRST AID

Old pet bedding should be removed and replaced with fresh bedding after treatment of pet areas. Do not spray surfaces where spotting, staining or discoloration would be objectionable.
