
SIDE EFFECTS

Monitor your cat after application. Side effects may include skin irritation such as redness, scratching or other signs of discomfort. In some cases, vomiting or diarrhea may result due to grooming after treatment. If these or other side effects occur, consult your veterinarian or call us at 1-800-775-9416. TevraPet[™] FirstAct[™] Plus For Cats is fastacting, long-lasting, waterproof, and easy to use. TevraPet[™] FirstAct[™] Plus For Cats remains effective even after bathing, water immersion, or exposure to sunlight. TevraPet[™] FirstAct[™] Plus For Cats can also be used for the treatment and control of flea, tick, and chewing lice infestations on breeding, pregnant and lactating queens.

Do not allow your cat to ingest this product. Do not apply to cats weighing less than 1.5 lbs. and less than 8 weeks old. Do not use more than one applicator per cat.

To kill fleas, flea eggs and larvae, all stages of **Brown Dog ticks, American dog ticks, Lone Star ticks,** and **Deer ticks** (which may carry Lyme disease), and chewing lice, apply this product to cats and kittens weighing over 1.5 lbs. and 8 weeks or older as follows.

HOW TO APPLY:

1. Prepare applicator as shown in "How to Open".

2. Part the hair on the neck at the base of the skull until the skin is visible. Place the tip of the applicator on the skin and squeeze the applicator to apply the entire contents directly on the skin of your cat. Do not allow your cat to ingest this product, or get the product into their eyes. Proper placement of the product on your cat will minimize the opportunity for the cat to lick and ingest the product. Carefully avoid allowing the product to run off the side of the cat.

3. Discard empty applicator and packaging as described in the Storage and Disposal section.

4. Under normal conditions the product remains effective for a month. In cases of severe flea infestation, retreatment may be necessary earlier than one month. Do not reapply TevraPet[™] FirstAct[™] Plus For Cats more often than once every seven (7) days. Once flea control is attained, return to a monthly application schedule.

FREQUENCY OF APPLICATION

Fleas: When used monthly, TevraPet[™] FirstAct[™] Plus For Cats kills all stages of the flea life cycle and orevents reinfestation of fleas on your cat for up to six weeks after application. Although TevraPet[™] FirstAct[™] Plus For Cats can control fleas for up to six weeks, if there is a high risk of re-infestation of fleas on your cat, or if the cat has fleas which may cause flea allergy dermatitis, apply TevraPet[™] FirstAct[™] Plus For Cats once every 30 days. **Ticks:** TevraPet[™] FirstAct[™] Plus For Cats kills all stages of the tick life cycle (larvae, nymph, and adult) for at least 30 days. For best control of ticks, apply once every 30 days.

Chewing Lice: TevraPet[™] FirstAct[™] Plus For Cats kills chewing lice for at least 30 days. For best control of chewing lice, apply once every 30 days.

Do not reapply TevraPet[™] FirstAct[™] Plus For Cats for 30 days.
